Section 3 - Hazards Identification

*** Emergency Overview ***: High vapor concentrations can irritate eyes, nose and respiratory passages. Causes nose and throat irritation. Harmful if inhaled. Section 6 - Accidental Release Measures

Steps To Be Taken If Material Is Released Or Spilled: Eliminate all ignition sources; use explosion-proof equipment. DO NOT use combustible materials such as sawdust.

Section 7 - Handling And Storage

Handling: Wash thoroughly after handling. Follow all MSDS/label precautions even after container is emptied because it may retain product residues. Use with adequate ventilation. Wash hands before eating.

Storage: Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Keep away from heat, sparks, flame and sources of ignition. Keep container closed when not in use.

Section 8 - Exposure Controls / Personal Protection

Engineering Controls: Prevent build-up of vapors by opening all doors and windows to achieve cross-ventilation. Use process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits.

Respiratory Protection: A respiratory protection program that meets OSHA 1910.134 and ANSI Z88.2 requirements must be followed whenever workplace conditions warrant a respirator's use.
