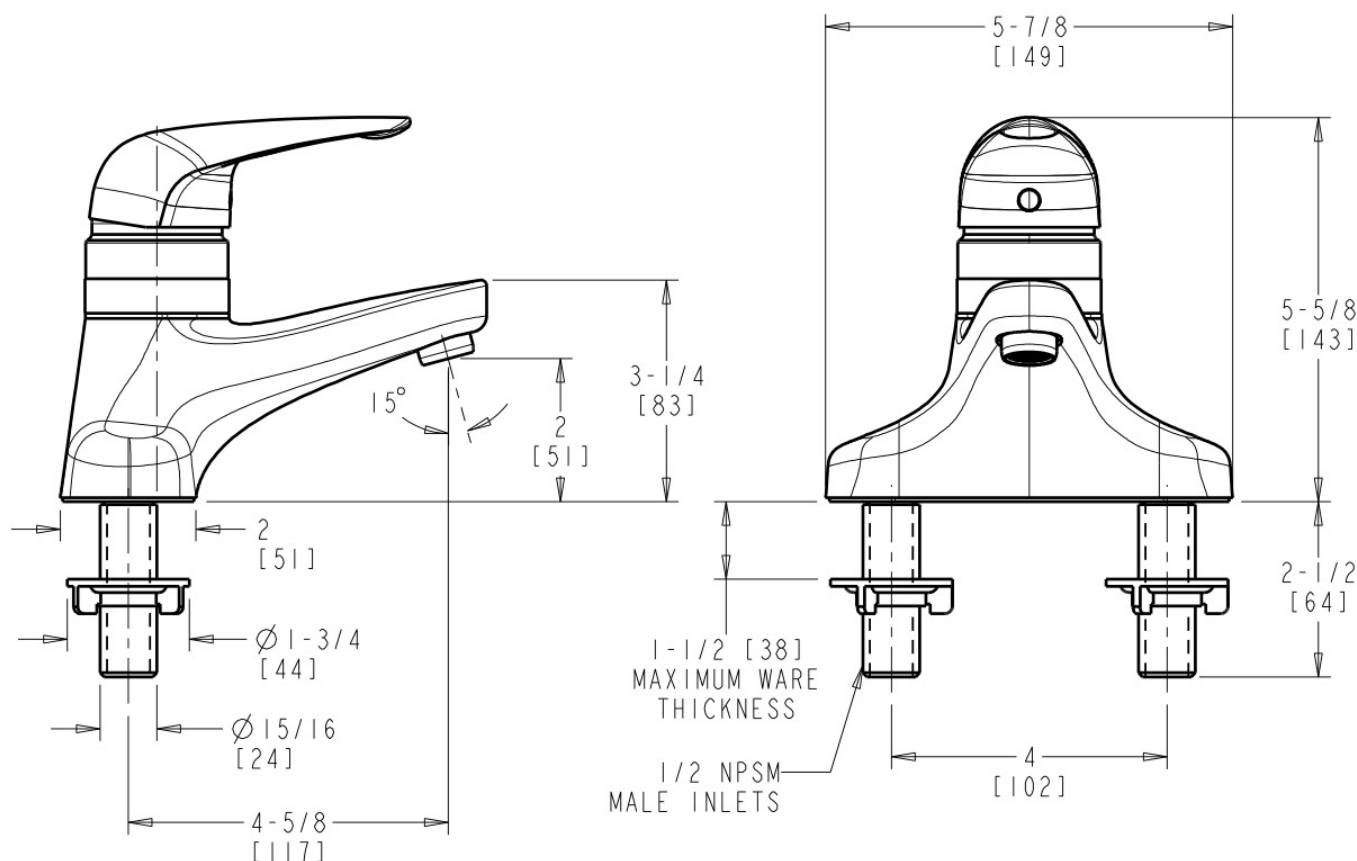

Rigid, cast brass spout, 4-5/8" center-to-center. 0.35 GPM (1.3 L/min) vandal-proof, non-aerating outlet. Ceramic mixing cartridge, includes thermostatic scald protection. Cartridge includes Integral inlet check valves to protect against cross-flow, 1/2" NPSM supply inlets for 3/8" or 1/2" flexible riser. ECAST® construction with less than 0.25% lead content by weighted average. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, ASSE 1070/ASME A112.1070/CSA B125.70, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.
