

Hazard statement

Extremely flammable aerosol. Contains gas under pressure; may explode if heated. Toxic if swallowed. May be fatal if swallowed and enters airways. Causes skin irritation. 4. First-aid measures

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.

Skin contact

5. Fire-fighting measures

Suitable extinguishing media Water fog. Alcohol resistant foam. Carbon dioxide (CO₂). Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Remove all possible sources of ignition in the surrounding area. Keep out of low areas.
