As a designer or contractor of a gunite pool you can be assured the fit of our sockets and spigots will be companion to your other components. All sockets and spigots comply with ASTM D2466 "Poly(Vinyl Chloride) (PVC) Schedule 40 Socket Type Fittings". The socket end accepts a standard IPS pipe; whereas the spigot is identical diameter to IPS pipe and will fit into the socket of a fitting of the same size.

Test results show the LASCO Venturi Tee will provide superior action in in relation to the volume of air which is drawn into the jet stream. This combination results in the ACTION your customer wants. The LASCO nozzle has been designed to eliminate changes when used with additional jets.





One venturi tee for each 10 to 15 GPMs. Attempting to "push" excessive flow through a venturi tee demands very high system pressures.
