- Mounts on wall or backboard.
- Route cable bundles adjacent to wiring base.
- Mount to Leviton 89 Stand-Off Brackets, providing space for routing cables behind each block.

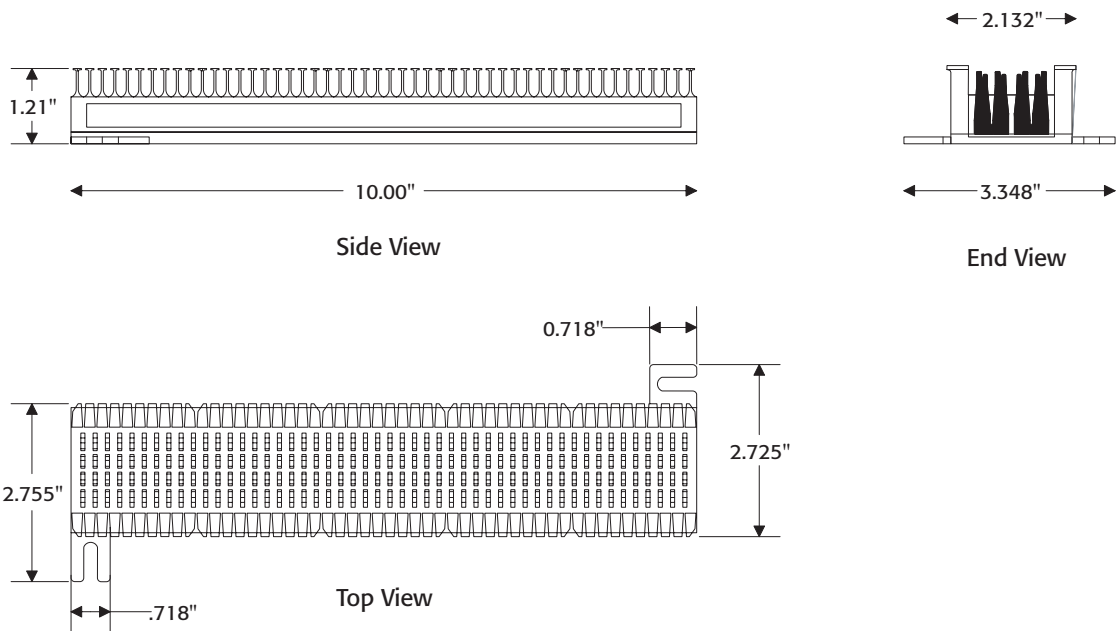
