4. First-aid Measures

FIRST AID - EYE CONTACT: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

FIRST AID - SKIN CONTACT: Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists.

SPECIAL FIREFIGHTING PROCEDURES: If water is used, fog nozzles are preferred. Water may be used to cool closed containers to prevent buildup of steam.

6. Accidental Release Measures

7. Handling and Storage

Follow all MSDS/label precautions even after container is emptied because it may retain product residues. Avoid breathing fumes, vapors, or mist. Avoid contact with eyes, skin and clothing.

STORAGE: Keep container closed when not in use. Store in a dry, well ventilated place. Keep container tightly closed when not in use.

PERSONAL PROTECTION

10. Stability and Reactivity

CONDITIONS TO AVOID: Avoid contact with strong acid and strong bases.

INCOMPATIBILITY: Not applicable for this product. Incompatible with strong oxidizing agents, strong acids and strong alkalies.

HAZARDOUS DECOMPOSITION: May produce hazardous fumes when heated to decomposition as in welding. Fumes may contain: carbon monoxide, carbon dioxide, chlorine, hydrogen chloride, cyanide, and methylene diphenyl diisocyanate. When heated to decomposition, it emits acrid smoke and irritating fumes.

HAZARDOUS POLYMERIZATION: Will not occur under normal conditions.

STABILITY: This product is stable under normal storage conditions.

11. Toxicological information

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Irritating, and may injure eye tissue if not removed promptly.

No significant exposure to Titanium Dioxide is thought to occur during the use of products in which Titanium Dioxide is bound to other materials, such as in paints during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.
