

Notwithstanding the foregoing Spirax Sarco shall have no obligation hereunder if all payments due from Purchaser have not been made, or the product or part becomes defective in whole or part as the result of repairs not made by Spirax Sarco or Purchaser, or as the result of removal, improper use, operation above rated capacities or misapplication thereof after it has been delivered to the Purchaser.
